In Q3 2025, the Company recorded activities that increased revenue and profit after tax, specifically as follows:

+ Net revenue from goods sold and services rendered increased by VND 225,132,054,824, equivalent to an 80.31% rise compared to the same period last year.

The cost of goods sold rose by VND 214,516,790,646, equivalent to a 78.25% increase year-on-year, mainly due to fluctuations in finished steel prices and input material purchase prices.

+ Financial income increased by VND 1,399,122,858, equivalent to a 1,832% growth compared to the previous period, primarily due to exchange rate fluctuations.

These were the main factors contributing to the profit after corporate income tax in Q3 2025, changing from a loss to a profit compared to the same period last year.
