**Disclosure content**: Explanation of Profit After Corporate Income Tax in the Income Statement for Q1/2025, which increased by 11% compared to the same period in 2024.

Profit after tax in the Q1/2025 financial statements of Haiphong Electricity Water Machine Assembly Joint Stock Company is VND 9,779,939,952 an increase of VND 1,211,097,771 compared to the same period in 2024, equivalent to an 14% increase.

The main reasons for the increase in profit after tax are as follows:

- 1. Revenue from sales and service provision increased:Increased by VND 24,544,974,962 equivalent to a 13% rise compared to the same period last year. This was the primary driver of the profit growth during the period.
- 2. Administrative expenses decreased:
  Decreased by VND 385,709,379 equivalent to a 7% reduction compared to
  Quarter I/2024, contributing to improved operational efficiency.
- 3. Financial expenses increased:
  Increased by VND 2,041,854,912 compared to the same period. However, this increase was offset by the rise in revenue, thus not negatively impacting the overall profit growth.

Aside from the reasons mentioned above, the Company confirms that there is no other information materially affecting the financial statements for Quarter I/2025.
