2.1. Election of Additional Members of the Board of Directors:

- Possessing professional qualifications or experience in business administration or in the fields or industries related to the Company's business activities, and not necessarily being a shareholder of the Company;
- A Member of the Board of Directors may concurrently serve as a member of the board of Directors directors at at no more than five other companies.

2.2. Election of Additional Members Members of the Supervisory Board:

- 2.2.1. Number of additional Supervisory Board members to be elected: 02 members (as stipulated in the Company's Charter).
- 2.2.2. Criteria and eligibility conditions for candidacy as a Member of the Supervisory Board:
- Not being disqualified as stipulated in Clause 2, Article 17 of the Enterprise Law;
- Having been trained in one of the fields of economics, finance, accounting, auditing, law, business administration, or a field relevant to the Company's business activities;
- Not being a family member of any member of the Board of Directors, the General Director, or other managers of the Company;
- Not being a manager of the Company and not necessarily being a shareholder or employee of the Company;
- Not being a family member of any manager of the Company, its parent company, the representative of the enterprise's capital, or the representative of the State's capital at the parent company or the Company.
- In addition to the above criteria and conditions, a Member of the Supervisory Board must not fall under the following cases:
- Working in the Company's accounting or finance department;
- Being a member or employee of an independent auditing firm that has audited the Company's financial statements in the three preceding years.
