The net profit after Tax of Son La Sugar Joint Stock Company for Quarter 3 of the fiscal year 2024-2025 decreased by 12,996,983,409 VND compared to the same period in the fiscal year 2023-2024. The main reasons for this decrease are as follows:

In the domestic sugar market in Quarter 1/2025 (Quarter 3 of the fiscal year 2024-2025), supply exceeded demand. Additionally, due to the impact of smuggling, the selling price of sugar products dropped significantly, resulting in a decrease in gross profit margin, which led to a reduction in profit for this quarter compared to the same period last year.
