3. Supervisory Activities of the Board of Directors over the Board of Management

Based on the Resolution of the General Meeting of Shareholders and within its authority, the Board of Directors approved and assigned the company's Board of Management to implement. The Board of Directors' evaluation activities with the company's Board of Management focused on the following contents:

3.1 Supervision of organizational structure

The Company maintains its organizational model in accordance with the Enterprise Law and the Company's Charter of Operations.

The Company identifies the supervision of the organizational structure as a crucial task in the Board of Directors' supervisory activities over the company's Board of Management, directly related to the organizational apparatus, operational activities, and the Company's efficiency. Given the specific nature of the Company's business operations, upon the proposal of the company's Board of Management, the Board of Directors approved the Company's organizational system, assigning responsibilities to the company's General Director, Deputy General Directors, enterprise directors, deputy directors, and heads and deputy heads of company departments and divisions, based on maximizing the capacity,

intellect, and responsibility of individual leaders in performing their duties, and enhancing smooth coordination and mutual support in carrying out their functions and responsibilities.

3.2 Supervision of Production and Business Activities (PBA)

Regularly inspect and evaluate the Company's monthly and quarterly Production and Business Activities (PBA) results. Additionally, the Chairman of the Board of Directors and the company's Board of Management, along with the heads and deputy heads of company departments and divisions, participate in regular meetings twice a month to evaluate and supervise the execution of PBA tasks and professional duties of the company's departments, divisions, and subordinate units, while simultaneously resolving difficulties arising in the Company's operational activities; identifying subjective and objective factors to promptly implement appropriate remedial measures.

The Board of Directors, especially the Chairman of the Board of Directors, always directly and closely supervises each company department, division, and enterprise, thereby promptly resolving difficulties arising in the Company's operations. In the first 6 months of the year, the Company developed specific work programs with its subordinate units (according to the semi-annual work plan) and organized preliminary review meetings and specialized briefings to evaluate the implementation status of PBA tasks, in order to promptly propose solutions and measures to enhance the efficiency of PBA.

The monitoring results indicate that the company's Board of Management has decisively implemented production and business activities and that measures to cope with difficult situations were applied promptly and appropriately, proving effective in production and business.

In the first 6 months of 2025, the Company effectively deployed and organized the implementation of several key areas of work, such as: strengthening the application of sales prices for electricity and water users in accordance with regulated prices; controlling electricity purchase costs; supervising the efficient operation and management of electricity and water, and saving water production costs, etc.

3.3 Other monitoring activities

- Monitoring of operational implementation: The Chairman of the Board of Directors and the General Director assigned tasks to the company's departments and enterprises, organized timely meetings with relevant departments to resolve issues within their authority, and promptly sought guidance from the Board of Directors on major matters concerning the Company's operations.

- Fulfilling budget contribution obligations to the state; paying employees' salaries promptly and according to regulations.

- Maintaining unity and consensus throughout the Company: there were no internal conflicts within the entire Company.

In the first 6 months, the Board of Directors meticulously performed its supervisory duties in strict accordance with the company's Charter and Internal Regulations on Corporate Governance, as per legal provisions, bringing the highest efficiency and benefits to the Company and its shareholders. Through supervision, the Board of Directors assessed that the company's Board of Management managed the company's production and business activities with great effort and achieved encouraging results.
