Disclosure content: Explanation of the Increase in Profit After Corporate Income Tax.

The profit after corporate income tax reported in the Statement of Profit or Loss for the third quarter of 2025 increased by 30% compared to the same period in 2024.

The profit after tax in the Quarter III/2025 Financial Statements of Haiphong Electricity Water Machine Assembly Joint Stock Company reached VND 18.7 billion, an increase of VND 4.3 billion compared to the same period in 2024, equivalent to a 30% rise.

Reasons for the increase in profit after tax:

- Revenue increased by VND 73.5 billion, equivalent to a 26% growth.
- Cost of goods sold increased by VND 68.8 billion, equivalent to a 26% growth.
