2. Some key tasks to be achieved in 2024:

The Board of Directors always closely follows and directs Quang Ngai Water Supply and Sewerage and Construction Joint Stock Company. In 2024, the Company has successfully completed the tasks assigned by the General Meeting of Shareholders and the Board of Directors with the following main contents:

- Invest in 01 surface water treatment cluster with a capacity of 6,000 m3/day and complete the system of level 1 and level 2 pumps, inverter electrical cabinets at VSIP Water Treatment Station to serve production and water supply at VSIP Water Treatment Station, ensure water supply for VSIP Industrial Parks, Tinh Phong and part of Chau O town and surrounding areas, increasing the capacity of VSIP water treatment station from 5,000 m3/day to 10,000 m3/day.
- Put into operation management and operation 58/56 items of water supply pipelines with diameters from D63 ÷ D315 HDPE under the project of 45,000 m3/day.night to ensure to serve the water needs of the people. In particular, there is a D315HDPE pipeline to transport water from the VSIP Station to supplement the water supply to Quang Ngai city; the D315 water supply pipeline through Nguyen Trai street is continuously connected and transfers water from the North to the East South of Quang Ngai city and La Ha town through the D315 pipeline Nguyen Dinh Chieu Nguyen Trai Le Loi street. After being put into use, it has significantly improved the flow and water pressure for the area with water shortage at peak hours in the South-East and South-West of Quang Ngai city and La Ha town.
- Investment in the development of the water supply service pipe network in 2024: The construction has been completed and water supply to the people in the residential area of Phuoc Dien Pagoda, Go Cat residential area of Nghia Chanh ward according to the Company's commitment to the people and local authorities in the above area.
- Coordinate with the consultancy unit to complete the preparation of dossiers of adjustment of groundwater exploitation licenses for district branches and have been licensed by the People's Committee of Quang Ngai province for 03 water supply branches in Binh Son, Mo Duc and Duc Pho.
- In combination with the urban embellishment of Quang Ngai city, in 2024, the Company has invested in installing D63 HDPE service pipelines at alleys 363 Nguyen Trai, alley 425 Le Loi, alley 58 Mac Dinh Chi street, north of Tran Quang Dieu street (the section from Chu Van An street to house number 65 Tran Quang Dieu, alley 465/30 Nguyen Cong Phuong with a length of about 2,100 meters to replace degraded service pipes and zinc pipes.
- The Company has identified loss prevention as the top task in the near future, so in 2024 the Company has invested in equipment to detect leaks, initially implementing loss prevention.
- For the management and operation of the water supply pipeline network in 2024, the number of meters of new management pipes will increase by about 19km with

pipe diameters from D315-63 HDPE belonging to Quang Ngai City Water Supply Plant, Mo Duc Industrial Park, Duc Pho Industrial Park.

- Financial work: The company implements financial measures, increases revenue, reduces costs; monitor the roadmap for adjusting water prices when instructed.
- Organization of human resources: The company continues to consolidate the organizational apparatus of departments, factories and treatment stations.

II. ASSESSMENT OF THE MANAGEMENT OF THE BOARD OF DIRECTORS IN 2024:

1. General assessment of the operation of the Board of Directors:

In 2024, the Board of Directors has successfully completed the assigned tasks, operated in compliance with the provisions of the Law, Charter and regulations of the Company, well performed the role of management, directed the Board of Directors to operate the Company's production and business activities.

III. SUPERVISORY RESULTS FOR THE BOARD OF DIRECTORS OF THE COMPANY

1. Evaluation of production and business results

- Clean water consumption: 10.997 million m³, up 10.1% over the previous year.

Consider building a long-term stable company model in terms of breadth and depth.
- Propose reasonable, scientific, and thoroughly economical production and customer management measures in production and business activities, regularly analyze and evaluate for the Company's leaders to promptly make the right decisions.
- Continue to assess the quality of current human resources to have a plan for onthe-spot training and labor recruitment in the direction of improving the quality of human resources to meet the increasing job demand. Arrange human resources, executive apparatus, reduce executive focal points throughout the company in the direction of streamlining.

4. Future development plan

- In the production and business activities of the unit, continue with the motto "customer-centric in production and business activities" to strengthen the application of information technology and computerization to production and business to improve labor productivity and operational efficiency; gradually improve and improve the quality of customer service.
- Blowing and maintaining the flow of wells being exploited at the city's water production enterprise.
- Please apply for the policy of exploiting the surface water of the Tra Khuc River. Investment objectives to supplement water sources to supply water to Quang Ngai City and surrounding areas due to water shortage in the hot season and peak hours; the risk of the current groundwater extraction wells being affected by the construction of the project of embankment to prevent landslides and embellish the landscape on the south bank of Tra Khuc river and Tra Khuc bridge.
- Continue to complete the ongoing project to expand the water supply system of Quang Ngai city. Especially urgently adjust the design of the KV items at the head of Tra Khuc bridge in accordance with the common space of the embankment project, Ba To Park and Tra Khuc 1 bridge.
- Supplementing the network of water supply service pipes in alleys in the city, there are currently no service water supply pipelines.
- To invest in expanding the water supply area to the Northeast and Southeast communes of the city.
- Investment in increasing the capacity of the upstream part at Duc Pho Water Plant: Surface water treatment pressure filtration system G. Section 1: C. Capacity 5,000 m3/day
- Equip backup pump equipment for production in 2025 for the city's water production industry and 03 district-level industrial units.
- Installation of automatic monitoring systems for drilling wells for groundwater extraction according to Circular No. 17/2021/TT-BTNMT at Quang Ngai City

- Water Production Enterprise and Binh Son Mo Duc Duc Pho industries (planned from 2024).
- Construction and installation of HDPE service water supply pipelines to replace zinc pipes invested before the 1990s, which are now degraded, constantly breaking down and reducing local water quality.
- Digital transformation: The company's Board of Directors determines that digital transformation is a "vital" choice for water enterprises in the current and future period. Therefore, it will plan and gradually continue to implement digital transformation at enterprises in accordance with the current situation of the Company and the general trend to improve the quality of professional and effective water supply services in production and business, the implementation method based on existing human resources, refer to and learn from units in the same sector to implement step by step, slowly but surely.
- Coordinate with investors in the city and construction departments of the city to relocate pipelines on MLCN in Quang Ngai city.
- Continue to assess the quality of current human resources to have a plan for onthe-spot training and labor recruitment in the direction of improving the quality of human resources to meet the increasing job demand. Arrange human resources, executive apparatus, reduce executive focal points throughout the company in the direction of streamlining.
- Invest in improving the management and administration capacity of watershed water collection works. In the management of revenue recording, continue to implement in the direction of collecting through banks for customers using clean water; Improve the capacity of online recording and collection in a modern direction (applying information technology combined with manual methods), mobilizing customers to open accounts at banks to pay water bills, minimizing cash collection.
- Repair the working office, invest in installing solar power at the company's headquarters and Vsip water treatment station.
- Explanation of the Board of Directors for the audit opinion: *No*

IV. SOME PROBLEMS THAT EXIST IN 2024

Due to the requirement to upgrade and expand Ho Chi Minh City. Quang Ngai to strive for the time to become a grade I urban area, in which the city has paid attention to clean water targets to meet the prescribed criteria, from which traffic routes and new roads are expanded and renewed. Many routes and sections of traffic routes do not have sidewalks to install water supply infrastructure, so the distribution water supply pipeline and service pipe must go in the road to supply water to new areas and maintain water supply.

Over the past time, the Company has had to combine with the construction of projects to upgrade roads to avoid the case that the road has to be dug up to construct and install water supply pipes. Therefore, the Company is under great pressure to coordinate synchronously with construction units to relocate, repair when there is a

breakdown, etc. even outside of working hours to reduce losses and minimize the impact on maintaining water supply for customers.

Many large production water customers have produced clean water themselves (Sugar Joint Stock Company cluster) for internal use, which has led to a significant decrease in water revenue for production water purposes in 2024.

Many customers currently use domestic water from 2 sources (tap water and self-bore well water), so many households use very low monthly tap water of less than 5m3/month, these cases are considered unprofitable (the price of Tier 1 water is less than 10m3/month is only 70% of the average price) but businesses have to bear additional costs for recording water, collect and manage e-invoices and take care of customers.

Many new water pipelines have been developed at the request of voters and local authorities, many projects have synchronously invested in the water supply system, but the number of customers using tap water is too small (due to few people building houses to live in, using water to drill wells at the site), leading to the amount of water that must be flushed periodically to maintain water quality on the network than the amount of water used on the bill.

Some work contents have been included in the 2024 plan but have not been implemented in time such as: Implementing the preparation stage for the capacity expansion of Duc Pho Water Supply Branch; installation of automatic monitoring equipment; maintenance and maintenance of materials and equipment on the water supply network. The reason for the lack of implementation is due to objective factors such as the locality of Duc Pho town has not approved the general planning and land use plan, the Provincial People's Committee has not approved the adjustment of the task of An Tho surface water reservoir; the current status of the total ground of water extraction wells in the city must be adjusted to the planning due to the arising of provincial projects (the project of the embankment south of the Tra Khuc river, the expansion of Ba To flower garden, the construction of the new Tra Khuc 1 bridge has not been completed so far).

REPORT PRODUCTION AND BUSINESS RESULTS IN 2024; 2025 PLAN

Overview of the company's situation:

Quang Ngai Water Supply, Sewerage and Construction Joint Stock Company is a joint stock enterprise with contributed capital by the state.

After the issuance of additional shares to increase the charter capital from 54 billion to 200 billion from 10/2017, the specific share ownership rate is as follows:

+ Capital of strategic shareholders: 72,55 %

+ State capital in enterprises: 23,36 %

+ Capital of other shareholders: 4,09 %

Main production and business tasks:

- + Production and consumption of clean water;
- + Investment consultancy for water supply works;
- + Design and construction of water supply and drainage works;
- + Purchase and sale of specialized supplies for water supply and drainage.

b. Regarding clean water business:

- Exploiting and supplying clean water to meet the needs of existing customers. Regularly maintain pressure on the network to be stable. In some cases, the water supply had to be stopped due to objective factors such as: power outages, incidents due to the renovation,

upgrading and servicing of urban embellishments in Quang Ngai city and towns due to the construction of roads, leading to bursts and water pipe tanks.

The inspection, supervision, measurement and inspection of water meters according to periodic regulations, the detection and timely handling of burst points on the pipeline network, monitoring and operation of grade II pumping stations according to water consumption hours at water plants on a monthly basis, season to meet the demand and efficiency in production.

The process of water treatment and disinfection of clean water before supplying to consumers is strictly and strictly implemented under the supervision of the Quang Ngai Provincial Center for Disease Control.

The periodic flushing on the water supply network is ensured in accordance with regulations, regularly carried out by the pipeline network management department, strengthening the monitoring and inspection of water quality.

In 2024, continue to improve and strengthen the application of information technology to online collection and the collection of water bills through banks. The results so far have shifted 100% to online water recording on smart phone devices; the rate of water bill collection through household collection reached over 90%, transfer collection was about 3%, cash payment was 6%.

- 5. Supplementing the network of water supply service pipes in alleys in the city, there are currently no service water supply pipelines.
- 6. To invest in expanding the water supply area to the Northeast and Southeast communes of the city.

- 7. Investment in increasing the capacity of the upstream part at Duc Pho Water Plant: Surface water treatment pressure filtration system G. Section 1: C. Capacity 5,000 m3/day
- 8. Equip backup pump equipment for production in 2025 for the city's water production industry and 03 district-level industrial units.
- 9. Installation of automatic monitoring systems for groundwater extraction wells according to Circular No. 17/2021/TT-BTNMT at Quang Ngai City Water Production Enterprise and Binh Son Mo Duc Duc Pho industrial facilities.
- 10. Construction and installation of HDPE service water supply pipelines to replace zinc pipes invested before the 1990s, which are now degraded, constantly breaking down and reducing local water quality.
- 11. Digital transformation: The company's Board of Directors determines that digital transformation is a "vital" choice for water enterprises in the current and future period. Therefore, it will plan and gradually continue to implement digital transformation at enterprises in accordance with the current situation of the Company and the general trend to improve the quality of professional and effective water supply services in production and business, the implementation method based on existing human resources, refer to and learn from units in the same sector to implement step by step, slowly but surely.
- 12. Coordinate with investors in the city and construction departments of the city to relocate pipelines on MLCN in Quang Ngai city.
- 13. Continue to assess the quality of current human resources to have a plan for on-the-spot training and labor recruitment in the direction of improving the quality of human resources to meet the increasing job demand. Arrange human resources, executive apparatus, reduce executive focal points throughout the company in the direction of streamlining.
- 14. Invest in improving the management and administration capacity of watershed water collection works. In the management of revenue recording, continue to implement in the direction of collecting through banks for customers using clean water; Improve the capacity of online recording and collection in a modern direction (applying information technology combined with manual recording methods), mobilizing customers to open accounts at banks to pay water bills, minimizing cash collection.
