The total number of shareholders representing shareholders entitled to attend the Annual General Meeting of Shareholders of the company is 10,352 shareholders,



representing a total of 173,490,193 shares, equivalent to 100% of the total number of voting shares.

As of 2:05 PM on May 22, 2025, the number of shareholders attending the meeting in person and under authorization is 67 shareholders, representing 74.127.620 shares, corresponding to 42,73% of the total number of shares entitled to attend the meeting of the Company.

Based on the 2020 Enterprise Law and the Company's Charter, the General Meeting of Shareholders can be conducted when the number of shareholders attending the meeting represents at least 50% of the total number of voting shares. Thus, with the percentage of voting shares attending the meeting being 42,73%, the first 2025 Annual General Meeting of Shareholders of IDJ Vietnam Investment Joint Stock Company does not have sufficient conditions to proceed.
