### I. Activities of the General Meeting of Shareholders

The Annual General Meeting of Shareholders 2025 of Safoco Foodstuff Joint Stock Company was held on April 09, 2025. The Meeting was attended by 40 shareholders and authorized representatives, representing 10,999,913 shares, equivalent to 91.31% of the total voting shares, ensuring the conditions for conducting the meeting as stipulated.

At the Meeting, important contents were approved by shareholders with a unanimous vote of 100% of the total voting shares present.

## 3. Oversight activities of the Board of Directors over the Board of Management

Based on the Charter and the Regulations on Corporate Governance, the Board of Directors conducted inspections and oversight. In the first 6 months of 2025, the Board of Directors fully performed its oversight functions over the Board of Management as stipulated in the Law on Enterprises, the Charter, and the Company's internal regulations. The oversight was carried out proactively, promptly, and within the correct scope of authority.

Specifically, the Board of Directors monitored the implementation of the contents of the Resolution of the Annual General Meeting of Shareholders 2025; evaluated the progress of business production plan execution through periodic reports, financial reports, and quarterly operating results submitted by the Board of Management. Information disclosure was strictly supervised, ensuring full compliance with legal regulations and relevant internal rules.

The Board of Directors also supervised executive operations through requesting clarification or explanation of contents before deciding on matters within its authority as stipulated. All submitted contents were discussed and approved by resolution to serve as a basis for the Board of Management's implementation.

Through its oversight, the Board of Directors noted that the Board of Management has managed business production in the right direction, proactively, keenly, with appropriate and timely strategies aligned with the actual situation, complying with laws and internal regulations, thereby contributing to enhancing operational efficiency and limiting risks for the Company in the first 6 months of 2025.

### 4. Activities of the Board of Directors' subcommittees:

The Internal Audit Committee is a subcommittee directly under the Company's Board of Directors, with the function of examining and evaluating the completeness and effectiveness of the governance, risk management, and internal control systems to help the Company achieve its strategic, operational, compliance, and financial objectives. Additionally, it provides independent and objective advice on governance and internal control processes; analyzes data, makes recommendations for operational improvements; and participates in advising on the selection and oversight of independent audit services to ensure efficiency and cost-effectiveness.

In the first 6 months of 2025, the Internal Audit Department conducted inspection and evaluation activities focusing on key areas to support the Board of Directors in supervising and ensuring operational activities are aligned with strategic direction. Specifically:

- Reviewed and verified the Q1, Q2, and 2025 semi-annual financial statements;
- Reviewed the status of debts, receivables, and payables with external and internal partners; analyzed business performance results, including revenue, expenses, profit, and key financial indicators.
- Concurrently, assessed the overall business operations and identified favorable and challenging factors in domestic and international markets.

In addition, the Internal Audit Department also reviewed labor organization, salary and bonus policies, ensuring stable income consistent with the Collective Labor Agreement; and reviewed the inventory situation at the Company and sales points.

Audit activities were implemented using a risk-oriented approach, focusing resources on high-risk processes, units, and operations to ensure efficiency and timeliness in inspection and supervision.

#### **Internal Audit Results:**

In the first 6 months of 2025, the Internal Audit Department noted that the Company prepared and presented its Q1, Q2, and semi-annual financial statements in full compliance with Vietnamese accounting standards, corporate accounting regulations, and current legal provisions related to the preparation and presentation of financial statements. Accounting data was reflected truthfully and reasonably, with no material errors or unreasonable discrepancies found that would distort the reports.

The independent auditing firm, AASC Auditing Firm Company Limited Branch, conducted a review of the 2025 semi-annual financial statements. The auditor's conclusion indicated that there were no qualified opinions or material recommendations.

During the period, there were no changes in accounting policies, accounting standards, or tax policies affecting the Company's financial position or the Company's published reports.

Regarding operational management, the Company continued to implement a comprehensive management system including supervision, evaluation, training, and transparent human resource policies, to ensure compliance with laws and internal regulations. The Company maintained a safe, fair, and healthy working environment; strictly fulfilled financial obligations to the State, employees, and relevant parties. Risk management continued to be effectively maintained, with timely risk identification, proposal of appropriate response measures, and organized monitoring and evaluation of implementation effectiveness.

Based on that, the Internal Audit Department proposed that the Board of Management continue to implement solutions to stabilize and develop business operations, prioritizing the maintenance of existing markets while actively expanding domestic and international distribution networks. Concurrently, focus should be placed on improving the quality of the sales team in terms of both professional expertise and market capabilities; maintaining periodic evaluation mechanisms, updating and refining risk control processes; strengthening cost control, optimizing cash flow management, and promoting the application of information technology in governance to enhance operational efficiency.
