## 3. Supervising the Board of Management (BOM) by the Board of Directors (BOD):

- The BOD has carried out their oversight and direction over the BOM on SAIGONBANK's business in line with the orientation and strategic targets; the solutions have been proactively and consistently performed, to assure a good alignment with the expected roadmap and certain aims. Plus, the business results already outperformed the assigned targets set by the General Meeting of Shareholders (GMS).
- In meeting sessions of the BOD, the General Director has reported about the operation of SAIGONBANK, about executing the Resolutions of the GMS and the BOD, about the obstacles and hindrances during resolution executing process. Accordingly, given the business review, operation evaluation and market scenarios analysis, the BOD has timely issued certain Resolutions on direction and instruction.
- The BOD has directed SAIGONBANK to strictly comply with the policies of the Government and the State Bank of Vietnam (SBV) in banking operation; properly implemented regulations on limits and adequacy ratios during the course

of business; directed the BOM to continue to maintain managing solutions for stable banking activities, to meet the liquidity requirements.

Directing how to execute the Restructuring Plan for the period 2021-2025, under the direction of the Prime Minister and the State Bank of Vietnam; supervising the implementation of the Restructuring Plan, ensuring healthy operation of SAIGONBANK, high quality, efficiency, publicity, transparency, and legal compliance.

Directing the adjustment and supervision over the implementation of regulations, procedures and internal management rules of SAIGONBANK, ensuring the compliance with Government regulations and aiming to adopt advanced international practices and standards.

- Instructing the BOM on tight management about the quality of lending activity, assuring good alignment with the fund growth, complying with the credit growth targets assigned by the SBV. In the course of 2024, SAIGONBANK has introduced various credit packages of preferential lending rates at 4.9% per annum and above, allocating a fund of above 5.000 billion dong to enable business and manufacturing recovery of the enterprises and the community; offering rate deduction of 1% per annum to customers who suffered from the storm No.3, providing funds for constructing social houses and for financing the social house purchasers in different local areas. Loan outstanding balance of 2024 increased by 10,39% (2.117 billion dong) against the beginning of the year.
- Internal Audit Department (under the BOS) regularly conducts the remote monitoring toward the operations of units, the implementation of the General Director's instructions from time to time and reports to the BOD, BOS, and BOM.
- In the year 2024, the BOD and BOM proactively and timely issued the policies, action programs, proposed appropriate solutions focusing on the implementation of business pushing remedies, speeding up the handling progress and concentrated to settle and resolve difficulties, obstacles faced by each branch units in the entire system, assuring the business growing aims to be fulfilled.

Given the aims of improving or serving quality, assuring the best security and privacy for the customers, SAIGONBANK has invested in servers and upgraded Oracle database management from version 10g to 19c, as well as successful data migration between old and new servers. The year 2024 also marked the success of launching biometrical identification function on SAIGONBANK Smart Banking in line with the prerequisites and expected roadmap defined by the SBV.

Following the prevailing market trends, SAIGONBANK has delivered financial services and products on high tech and digital facility to the clienteles such as apps namely SAIGONBANK smart banking, SAIGONBANK pay, eKYC function, online savings... having the customers rest assured with high security and privacy during their banking journey with us.

SAIGONBANK has boosted the payment connection for public services, as well as set up points of direct Tax/Duty or fee collection in Thu Duc City and districts/subdistricts... to bring the convenience, efficiency, and speed to customers' transaction experience, to give an effort for forming cashless payment habit upon the directives of the Government.

- Fostering the capability of planning work, monitoring and managing the financial aspects of SAIGONBANK's business, controlling the operational expenditures; flexibly managing fund balancing and interest rate policy; as well as prudently controlling asset quality and credit assessment, risk management to be strengthened on an on going basis.
- Spreading the propaganda and advertisement for SAIGONBANK trade name, enabling the approachability of ourself and our banking products to a wider public via social, humanitarian and community financing program: working closely as a companion with the program of free optical surgery for the poor patient and the program of the 1000<sup>th</sup> operation, offering drinking water to people in areas of drought and salt marsh, handing over gifts to offsprings of the union labors who have struggled with difficult situations in Can Tho City; financing the festival Ooc Om Boc Dua Ghe Ngo of Soc Trang province in 2024, carrying out charity work, donating through the Central Committee of Vietnam Fatherland Front and local administration units to help people in the North with the aftermath situations.

## 4. Activities of Committees under the BOD (if any):

According to the regulations of the SBV, the BOD has established the Human Resources Committee and the Risk Committee:

## 4.1. Human Resources Committee:

The Human Resources Committee (HRC) was established under Decision No.76/QD-HDQT dated April 28, 2010, of the BOD in accordance with the provisions of the law and has been improved several times to suit SAIGONBANK's actual operation from time to time. In 2024, HRC has performed its functions, tasks and reportedly achieved following results:

- Strategically advising the BOD on matters within the BOD's authority including developing human resource policy, selecting and appointing personnel to positions within the BOD's authority; defining regime on salary, remuneration, bonus for employees at SAIGONBANK; assisting the BOD in supervising the execution of regime, policy on human resources and other human resource management activities of SAIGONBANK;
- Consulting the BOD on handling personnel issues that have arisen during the process of electing, appointing, dismissing, removing officials in accordance with statutes, regulations;
- Overseeing SAIGONBANK's compliance with the provisions of the law on utilizing the human resources;

- Proposing to send managerial officers, staff to training programs, symposiums to have their knowledge stay abreast of prevailing legal requirements and to improve their professions;
- Through HRC's advisory work, the BOD has given timely attention and direction, thereby enhanced SAIGONBANK's qualified human resources, especially in developing an IT talent pool that possesses high level of specialty and professionalism to fulfill the personnel demand of banking industry within the current context of digital transformation.
- Regarding organizational structure, HRC has advised, improved organizational model in the direction of streamlining, specializing and clearly defining functions, tasks, effectively enhancing cooperation among departments and business units.

#### 4.2. Risk Committee:

The Risk Committee (RC) was established under Decision No.77/QD-HDQT dated April 28, 2010, of the BOD in accordance with the provisions of the law and has been improved several times to suit SAIGONBANK's actual operation from time to time. By strictly sticking to SAIGONBANK's business plan for 2024 and operations, RC has performed its functions, tasks as follows:

- Strategically advising the BOD on issuing regulations and policies of risk management within the BOD's authority in accordance with the provisions of the law and SAIGONBANK's charter;
- Analyzing, issuing warnings about the potential risks that could possibly impact the safe business of SAIGONBANK and measures for preventing these risks in short term as well as long term.
- Reviewing, assessing the congruence and effectiveness of SAIGONBANK's risk management procedures, policies to make recommendations, proposals to the BOD on requirements for changes to current procedures, policies and strategies.
- Consulting the BOD for approving SAIGONBANK's investments, related transactions, governance policy and risk resolving plan within the scope of functions and tasks assigned by the BOD.
- Reviewing and deciding SAIGONBANK's significant risks portfolio, thereby developing active solutions in managing and mitigation risks. In particular, the management, recovery and handling bad debts, doubtful debts has been given top priority, which is appropriate with general policy of the Government and the SBV;
- Supervising the implementation of Circular No.41/2016/TT-NHNN dated December 30, 2016 (amended and supplemented) of the SBV prescribing prudential ratios for operations of banks and Circular No.13/2018/TT-NHNN dated May 18, 2018 of the SBV prescribing internal control systems of commercial banks; advise the BOD on issuing regulations, policies within the BOD's authority related to risk

management for SAIGONBANK's operation as provisioned by the law. In 2024, SAIGONBANK has issued 12 regulations, policies on risk management in accordance with Basel II standard;

- -Regularly observing the execution of SAIGONBANK's risk management policies; timely producing risk warnings and respective recommendations for SAIGONBANK's regulations, policies and services;
  - Advising the BOD on supervising the implementation of critical risk limits.
- Advising the BOD on controlling the balanced capital position and liquidity, interest rate risk management to ensure safety, effectiveness and the compliance with regulatory limits for the Bank's operation.
- Advising the BOD on the execution of liquidity, market, operation and credit risk management in the entire system. Building, creating a governance structure that shall be systematic, consistent, effective and suited to the Bank's operation scale.
