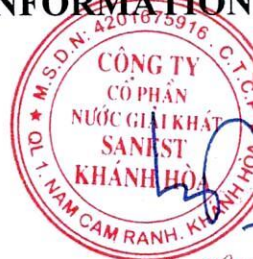

Khanh Hoa Sanest Soft Drink Joint Stock Company provides an explanation regarding the increase in after-tax profit in the Consolidated Financial Statements for Q4/2025 compared to the same period in 2024, as follows:

In Q4/2025, the economic situation remained challenging, and consumer purchasing power in the food and beverage industry had not truly recovered; natural disasters, storms, and floods in many localities nationwide impacted the Company's production and business activities. Furthermore, implementing the policy of continuing to consolidate the distribution network, especially focusing on developing retail points in the market, the Company proactively adjusted the production and business plan targets for Q4/2025 to reduce inventory pressure on the distribution system, as well as planning the production and launch of product lines with packaging and labeling compliant with the regulations stipulated in Circular No. 29/2023/TT-BYT, effective from January 01, 2026.

By implementing restructuring and streamlining solutions, accelerating digital transformation, and investing in machinery and equipment to increase automation in production, the Company achieved many positive changes in improving labor productivity and controlling costs. Consequently, business efficiency significantly improved, and profit after tax increased compared to the same period last year. Specifically, the Company's profit after tax in the Consolidated Financial Statements for Q4/2025 reached VND 15,852 million, an increase of 27.13% compared to the same period in 2024. For the accumulated year 2025, the Company's profit after tax reached VND 65,545 million, an increase of

16.49% compared to 2024, achieving 100% of the annual plan approved by the General Meeting of Shareholders.

Khanh Hoa Sanest Soft Drink Joint Stock Company respectfully informs the State Securities Commission, Ha Noi Stock Exchange, and Shareholders about the fluctuation in the Company's profit during Q4/2025.
