- Pursuant to the voting results at the Annual General Meeting of Shareholders of Thang Long Metal Wares Joint Stock Company on May 28th 2025;

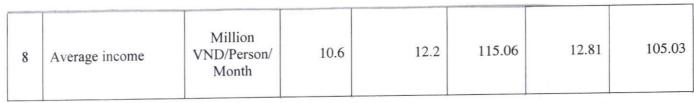
