RESOLUTION

Re: Approval of the plan to transfer the entire capital contribution in Huong Linh 8 Wind Power Joint Stock Company

THE BOARD OF DIRECTORS OF SCI JOINT STOCK COMPANY**Pursuant to:**

- *The Law on Enterprises No. 59/2020/QH14 passed by the National Assembly of the Socialist Republic of Vietnam on June 17, 2020, as amended and supplemented by Law No. 03/2022/QH15 passed by the National Assembly on January 11, 2022, and Law No. 76/2025/QH15 passed by the National Assembly on June 17, 2025, and its guiding documents;*

HEREBY DECIDES

Article 1:: To approve the divestment plan in Huong Linh 8 Wind Power Joint Stock Company, specifically as follows:

1. **Investment name:** Huong Linh 8 Wind Power Joint Stock Company;
2. **Number of divested shares:** 23,990,632 shares, equivalent to an ownership ratio of 67.01%;
3. **Ownership ratio after the transfer:** 0.00%, equivalent to 0 shares;
4. **Transfer method:** Selection of interested investors;
5. **Transfer price:** Not lower than the investment cost of VND 11,403/share.
6. **Expected transfer period:** Q2, Q3/2026.

Article 2:

To assign the Board of Directors and the Board of Management of SCI Quang Tri JSC to be responsible for selecting investors, and completing relevant dossiers and procedures in accordance with the law for implementation.



Article 3: Effectiveness and Execution
