Explanation:

Profit after tax in the first half of 2025 audited decreased 8% compared to non-audited due to the following reasons:

- Net revenue decreased by 4% equivalent to nearly VND 13 billion, because some export orders had initially been recognized when the goods were delivered to the seaport and completed customs clearance before June 30, 2025, but the goods were actually loaded on board the vessel after June 30, 2025. According to the trade terms (FOB, CIF) in the contract, revenue can only be recognized when the goods are loaded on board the vessel (based on BOL). Therefore, this revenue was adjusted and recognized in July 2025 instead of June 2025.
- Gross profit, Profit before tax and Profit after tax decreased because of the decreased revenue as above
