- The Board of Directors always closely works with the Company's Executive Board to work directly with the Provincial People's Committee, local authorities, and relevant authorities to remove difficulties in supporting investors; research to implement new projects; Support investment promotion activities, etc.
- The Board of Directors proactively supports the Board of Managements in foreign affairs activities, specifically connecting with local authorities to register the Company's needs for research to implement new investment projects, all research projects have high competitiveness (Industrial parks and industrial clusters are all on the list approved by the Prime Minister for the Provincial Planning and are included in the land use plan and

planning for the period 2021-2025). This is the strength of the VRG brand through the provinces' approval to assign VRG Company as the investor of industrial park projects; Industrial clusters are proof of the Company's reputation and ability to develop the brand nationwide.
