In accordance with the Charter on the organization and operation of BIDV and the Regulation on the organization and operation of the Board of Directors, during the first six months of 2025, BIDV's Board of Directors held **two regular** (quarterly) **meetings**, as detailed below:

In addition to the meetings mentioned above, the BIDV Board of Directors (BOD) also held thematic working sessions to exchange ideas, provide strategic direction, and ensure unified leadership over key matters of the BIDV system.

3. Supervisory Activities of the Board of Directors over the Executive Board

3.1. Results of BOD's Supervisory Activities

In the first half of 2025, the Board of Directors (BOD) conducted comprehensive, close, effective, and diverse supervision over the Executive Board through various forms. The BOD held regular quarterly meetings and several thematic meetings to approve and decide on critical matters of the system and to exercise high-level oversight of the Executive Board; acknowledged the Reports on the implementation progress of the BOD's Resolutions/Decisions and the Reports on monitoring, urging, and inspecting the tasks assigned by the BOD, the Chairman of the BOD, and BOD members, ensuring timely and quality completion as required.

The Board of Directors (BOD) issued a Resolution on the BOD's supervision plan at the beginning of 2025, which included thematic supervision contents aligned with the key focus areas of the BOD and the system. The plan was subsequently communicated to the Executive Board to serve as a basis for coordination and implementation. The Executive Board promptly and seriously developed and assigned specific tasks, directed relevant units to implement them diligently, and provided the BOD with complete and timely reports on the results achieved, as well as difficulties and obstacles encountered, along with proposed measures and solutions.

Based on the BOD's supervision plan, regular/thematic meetings were organized between the BOD/BOD members and the Executive Board as well as

relevant units; supervision reports on the implementation status of directives assigned by the BOD/the Chairman of the BOD/BOD members were submitted, ensuring timely and high-quality execution as required; periodic reporting regimes were implemented to support the BOD's supervision and governance activities; periodic/thematic supervision reports were prepared by supervisory advisory units... Through these activities, the BOD/BOD members were provided with complete, prompt, and accurate information to supervise the Executive Board and professional units in the implementation and execution of tasks in accordance with the BOD's directions and orientations.

In terms of content, during the first six months of 2025, the BOD's supervision of the Executive Board was synchronized and comprehensive, including: (i) Supervision of senior management in Supervision of the implementation of corporate governance and operations at BIDV. Notable supervisory topics carried out in the first half of 2025 included:

- Supervision of risk management with a focus on "Key risk indicators and safety ratios of the system";
- Thematic supervision on "Asset management to promote thrift and prevent waste";
 - Thematic report on system-wide credit quality supervision;
- Supervision of the implementation of the 2024 Strategy, including the overall strategy and component strategies (07 components), and a summary report on the Q1/2025 implementation of component strategies...;
- Continued supervision of the implementation of BIDV's restructuring plan for 2021–2025 in accordance with Resolution No. 538/NQ-BIDV dated May 21, 2024, including implementation reports for 2024 and Q1/2025...;
- Directive for the preparation of thematic reports on strategy-related research and governance activities, including: The BIDV competitiveness assessment report and market positioning evaluation compared to competitors (conducted semi-annually); Progress report on the Action Plan to implement the National Financial Inclusion Strategy for the 2020–2025 period.

3.2. Continued Development, Enhancement, and Implementation of BOD Supervisory Tools

In addition to implementing supervisory activities over the Executive Board, with the aim of enhancing the application of information technology (IT) to keep pace with global digital transformation trends and improve labor productivity, the Board of Directors (BOD) also directed the research, development, and upgrading of internal tools and software applications, as well as the improvement of regulatory documents and systems, in order to enhance the effectiveness of supervisory activities, specifically:

- (i) Completed the development of the Strategic Monitoring Report Program at BIDV (referred to as the SM Report Program). On a quarterly/semi-annual basis, the SM Report Program will generate official reports and automatically send emails to the Management Board summarizing the implementation results of the targets and the progress of the implementation of component strategies/long-term plans;
- (ii) Completed the issuance of the "Regulation on the reporting regime serving the governance and supervisory activities of the BOD" attached to Decision No. 367/QĐ-BIDV dated 16/4/2025 replacing Decision No. 659/QĐ-BIDV, ensuring the Executive Board's reports are fully monitored, streamlined, and timely followed up;
- (iii) Continued to research, upgrade, and maintain reporting application software serving high-level supervision in risk management, developing the coding rules for indicators, calculation formulas, and full threshold indicators to enable timely alerts.

In general, in the first six months of 2025, the supervisory activities of the BOD have been implemented in accordance with the approved programs and plans as well as promptly and flexibly directed the supervision of new and key issues of the system. Through the supervisory results, the BOD has promptly directed the Executive Board to urgently and seriously implement, fully and timely report to the BOD on the difficulties, obstacles, and propose measures and solutions for the BOD to consider and adjust within its authority, ensuring the supervisory activities of the BOD are effectively implemented.

4. Activities of the BOD Committees

Currently, BIDV has five Committees under the Board of Directors (BOD), including: the Risk Management Committee, the Human Resources Committee, the Strategy and Organization Committee, the Information Technology Committee, and the BIDV–Hana Bank Strategic Cooperation Committee. The BOD has issued specific regulations on the organization and operation for each Committee.

In the first half of 2025, the Committees fully and promptly performed their functions and duties in accordance with the Regulations on the organization and operation of each Committee. The specific results are as follows:

4.1. Risk Management Committee (RMC)

The RMC is under the BOD, functioning as an advisory body on issues related to system-wide risk management, aiming to enhance the effectiveness of the risk management system and foster a risk control culture throughout the BIDV system. In the first half of 2025, the RMC continued to focus on implementing its functions, duties, and activities in accordance with Circular No. 34/2024/TT-NHNN dated 30/6/2024 and Circular No. 13/2018/TT-NHNN, including: (i) Advising on the development, management, and supervision of the Bank's overall risk management framework; (ii) Advising the BOD in monitoring the implementation of key risk limits; (iii) Advising the BOD in overseeing the CEO's handling and remediation of deficiencies and limitations in risk management as requested and recommended by

the State Bank of Vietnam (SBV), independent auditors, internal auditors, and other regulatory agencies.

In general, the current functions and duties of the RMC have aligned with best practices, complied with SBV regulations, and focused on advising the BOD in formulating, managing, and monitoring the implementation of risk management policies and key risk limits across the Bank.

Specific activities carried out by the RMC in the first half of 2025 include:

(i) Advising the BOD on the development, management, and supervision of the Bank's overall risk management framework:

Advised the BOD to approve and issue Resolutions, documents, and policy mechanisms related to credit activities, risk management, overall risk management framework, internal capital adequacy assessment under Basel II practices, and in compliance with Circular 13 and Circular 41 of the SBV, including: ICAAP report; risk management policies, limits, and models such as: Market Risk Management Policy, Centralized Risk Management in Proprietary Trading Activities, BIDV's Overall Risk Management Policy Framework, Credit Granting Policy, and the Credit Risk Model Validation Framework.

(ii) Advising the BOD on risk management oversight across the system:

Advised the BOD on monitoring the implementation of key risk limits across the Bank, conducted thematic supervisory reports on capital adequacy, key risks, and safety ratios across the Bank; monitored compliance with Circular 13 and Circular 41 of the SBV at BIDV.

In the first six months of 2025, the RMC held two meetings, including one regular meeting to review 2024 performance results and discuss and agree on the key work program for 2025, and one thematic meeting on risk management in wholesale credit activities. The RMC meetings were conducted in accordance with its Regulation on organization and operation.

4.2. Human Resources Committee (HRC)

The HRC is a unit under the BOD with the function of advising, consulting, and assisting the BOD in formulating and implementing human resource management and development policies, including personnel, salary, bonuses, remuneration, and nomination/appraisal of candidates for positions such as BOD members, Supervisory Board members, Executive Board members, etc., as well as other personnel-related matters. In the first six months of 2025, the HRC advised the BOD on matters within the Committee's functions and duties, including:

- (i) Issuance of the Regulation on Responsibility Handling for Units and Individuals at BIDV under Decision No. 696/QĐ-BIDV dated 23/06/2025;
- (ii) Proposal to amend the job position salary scale stipulated in the Salary and Income Payment Regulation under Decision No. 246/QĐ-BIDV dated 31/03/2021 and the principle of arranging departments/centers and business groupings at the Head Office.

4.3. Strategy and Organization Committee (SOC)

The SOC is under the BOD, with the function of advising and assisting the BOD in addressing issues related to strategic governance, development strategy, business planning, organizational structure, and the governance model of the entire system.

In the first six months of 2025, the Committee performed the following tasks:

- (i) Conducted a year-end review of 2024 activities and developed the 2025 Work Program;
- (ii) Successfully fulfilled its role in advising and assisting the BOD on matters related to strategic governance, development strategy, business planning, organizational structure, and governance model of the entire system. Specifically, the Committee gave opinions on:
- The pilot implementation plan of the Cash Transit Point model in Hai Phong City;
- The operational model for anti-money laundering and compliance with sanction policies at BIDV;
- Consolidation of the management model and tasks of the CRM Project Management Board and several related units;
 - Amendment of the Strategic Governance Regulation;
- The report on corporate governance in the first six months of the year according to the ASEAN Corporate Governance Scorecard.

4.4. Information Technology Committee (ITC)

The ITC is a body under the BOD, functioning as an advisory and consulting unit to the BOD on matters related to information technology (IT), including the issuance of mechanisms and policies for IT operations, as well as directing, inspecting, and supervising IT activities... In the first six months of 2025, the ITC advised and consulted the BOD on the implementation of the IT and Digital Transformation Plan. At the same time, for issues and projects involving multiple departments/divisions at the Head Office, the ITC provided direction, guidance, and timely resolution of difficulties and obstacles in IT operations, with notable achievements including:

- (i) Held one regular meeting (Q2) to review proposals and provide opinions on the policy for procurement of a big data management platform following the Lakehouse architecture and the formulation of a comprehensive AI application plan across the BIDV system for the period 2025–2031;
- (ii) Completed the revision of the ITC's Operational Regulation to streamline workflows and improve productivity and efficiency;
- (iii) Provided consultation and opinions on 09 investment and procurement items for IT assets and services, and on the development and adjustment of the 2025 IT Plan under the BOD's approval authority;
- (iv) On a quarterly basis, supervised the progress of the implementation of directives (from meetings), the execution of the IT Plan, Digital Transformation Plan, and 2025 Software Development Plan; reported on the implementation status of key/critical IT projects under the 2025 IT Plan;

(v) Submitted reports in accordance with the meeting frequency of the Committees and reported on key IT projects of the ITC to the BOD and relevant control lines as issues arose.

4.5. BIDV – Hana Bank Strategic Cooperation Committee (SCC)

The SCC was established to support and advise the BOD in implementing technical assistance commitments and enhancing the effectiveness of the strategic cooperation between BIDV and Hana Bank, a member of Hana Financial Group. The year 2025 marks the beginning of a new phase in the cooperation between BIDV and Hana Bank following the signing of the extended Technical Assistance Agreement on 22/09/2024. The main activities of the SCC in the first six months of 2025 are as follows:

- (i) Issued Decision No. 135/QĐ-BIDV dated 07/02/2025 and Decision No. 141/QĐ-BIDV dated 12/02/2025 to supplement and consolidate SCC personnel; arranged and adjusted task assignments among the Committee members in accordance with the new phase of the BIDV Hana Bank Technical Assistance Agreement;
- (ii) Organized two programs of meetings/consultations of the SCC in accordance with its work plan: (+) Held one SCC meeting in January 2025 to focus on discussing and agreeing on the implementation plan for key cooperation programs in 2025 and set the orientation for the new phase of cooperation, in parallel with the transition of Hana Bank's seconded personnel; (++) Conducted one round of written consultation in April 2025 (Q1/2025) to review the progress of cooperative activities and consider proposals to strengthen cooperation in the FDI customer development segment;
- (iii) Directed and supervised 30 technical cooperation projects, ensuring timely and effective implementation; successfully organized one program inviting Hana Bank experts to BIDV to share experience on the centralized application management system project (SmartCounter Hub) in February 2025 and one market survey program in Korea in May 2025 with the participation of leaders from the SBV, BIDV, and NAPAS to support the implementation of the Vietnam Korea cross-border QR payment connection project.

In addition to the above regular meetings, the SB regularly collected written opinions or convened discussions to approve other matters under the SB's duties and functions in accordance with the law and the Charter.

3. Supervisory Activities of the SB over the BOD, CEO, and Shareholders

The SB conducted supervision on the following matters: (i) Supervising the governance and management activities at BIDV to ensure compliance with legal regulations, internal policies, BIDV's Charter, and the Resolutions and Decisions of the General Meeting of Shareholders (GMS) and the BOD; (ii) Supervising the observance of prudential limits and ratios to ensure operational safety of BIDV in accordance with the Law on Credit Institutions and the requirements of the State Bank of Vietnam (SBV); (iii) Supervising the approval of investment projects, fixed asset transactions, contracts, and other transactions under the approval authority of the GMS

and BOD; (iv) Supervising other matters as necessary or as requested by competent authorities. The SB performed supervisory activities through periodic and ad hoc supervision, or via internal audit activities. The SB focused on evaluating critical areas and key issues, providing proposals and recommendations to the BOD and CEO to help ensure BIDV's operations remain safe, compliant with the law, and to improve business performance.

The SB acknowledges that in the first six months of 2025, the governance and management activities at BIDV were carried out in accordance with the BIDV Charter, internal corporate governance regulations, and the Regulation on the Organization and Operation of the BOD. The BOD has fully and promptly implemented government directives, SBV instructions, and GMS resolutions, and issued resolutions and decisions to provide timely orientation and direction for the entire system. The CEO organized the execution of tasks and plans in line with the orientation and requirements set out in the BOD's resolutions and decisions.

4. Coordination Between the Supervisory Board (SB) and the Board of Directors (BOD), Executive Board, and Other Management Personnel

In the first six months of 2025, the SB submitted to the BOD for approval and issuance Decision No. 286/QĐ-BIDV dated 28/03/2025 on the Coordination Mechanism between the BOD, CEO, first-line defense units, second-line defense units, the SB, and Internal Audit (replacing Decision No. 706/QĐ-BIDV dated 24/07/2023), which updates new regulatory provisions under the Law on Credit Institutions 2024. The relevant parties have coordinated effectively, exchanging information in compliance with legal and BIDV regulations, and in the interest of the overall system.
