Profit after CIT on the parent company's financial statements and consolidation differed by over 10% over the same period last year, due to the fact that during the period, revenue from sales and services arising from the handover of real estate products decreased, leading to the difference in profit after tax in Q3/2025 compared to the same period last year on the parent and consolidate.

Explanation for the loss in profit after tax during the reporting period:

Due to the real estate market being negatively affected and remaining unfavorable, the Company temporarily did not accelerate new sales launches. As a result, in Q3/2025, the Company recorded a loss in profit after corporate income tax in both the Separate and Consolidated Financial



Statements. Specifically Separate Financial Statements: loss of VND 6.076.447.247 and Consolidated Financial Statements: loss of VND 7.397.915.336.
