  - 6.1. The audited financial statements of the parent company in 2024 are prepared on 25/03/2025, including: Report of the Board of Directors, Independent Audit Report, Balance Sheet, Report on business results, Statement on cash flows, Explanation of financial statements.
  - 6.2. Explanation of profit difference of 10% of profit after tax compared to the same period in 2023: profit after tax in 2024 will reach VND 51.840.445.522, an increase of VND 14.759.905.187 (an increase of 39.8%) over the same period in 2023 for the following main reasons:
    - + In 2024, Revenue from financial activities will reach VND 48.324.456.639, an increase of VND 6.170.001.629 (an increase of 14,64%) over the same period in 2023 due to the increase in dividends distributed from LBM's subsidiaries in 2024 compared to 2023.
    - + In 2024, Corporate management expenses decreased by VND 6.435.898.199 (a decrease of 46,31%) over the same period in 2023, due to the reimbursement of bad debt provisions due to the company's debt recovery.
