- 1. Profit after tax in the reporting period shows a variance of 5% or more before and after audit;**
- 2. Profit after tax in the statement of profit or loss for the reporting period has varied by 10% or more compared to the same period in the previous year;**
- 3. Profit after tax in the reporting period changes from a loss in the same period of the previous year to a profit in the current period:**
  - For 2024 audited financial statement, the company's profit after tax was - 713.586.204 VND.

- For 2025 audited financial statement, the Company's profit after corporation income tax is 526.673.006 VND. Compared to the same period of the previous year, the Company's profit after tax turned from a loss to a profit and increased by 173.81%.

**Reason:**

- In 2025, the Company effectively controlled its administrative expenses. The Company has recovered doubtful receivables that had been previously provided for in prior periods and has recognized a reduction in expenses in the current period.
- In 2025, the variance in profit after tax before and after audit arose from interest income on deposits.
