3. Supervising the Board of Management by the Board of Directors

Within the scope of the functions and duties defined by the Enterprise Law, the Company's Charter, the Corporate Governance Regulations, and the current laws, the Board of Directors has carried out the inspection and supervision of the CEO and the Executive Board's activities in managing production and business operations, as well as implementing the resolutions of the General Meeting of Shareholders and the Board of Directors during the first half of 2025, as follows:

- (i) The company completed, submitted, and disclosed periodic and extraordinary information in compliance with deadlines in 6 months of 2025.
- (ii) The BoD regularly exchanged updates and held periodic meetings to discuss the implementation of strategies, business plans, and resolutions of the BoD.

- (iii) The Chairman of the BoD held monthly meetings with the Executive Board to review the company's business operations, financial performance, compliance, risks, ongoing machinery improvement projects, capacity enhancement for factories, and projects at subsidiaries or affiliated companies.
- (iv) The BoD frequently discussed and approved decisions, resolutions, and timely directives for business planning and market strategies (domestic and export markets, retail market) based on reports from the CEO to ensure effective implementation.
- (v) Information channels were developed to facilitate stakeholders' access to disclosed information available on the websites of the State Securities Commission, Hanoi Stock Exchange (HNX), and the company's website.
- (vi) BoD members carried out monitoring activities in strict compliance with the law and the Company Charter, focusing on specialized business operations, market analysis (domestic and international), machinery upgrades, investment, and strategic planning.
- (vii) Overall, in the first half of 2025, these activities were conducted through meetings between the BoD and the Executive Board, during which the BoD worked directly, exchanged ideas, and questioned the Executive Board on issues related to business operations and the company's development direction.
- (viii) The BoD approved the audit firm, BoD members were tasked with supervising three critical aspects: financial status, compliance, and risk management.
