3. Supervisory activities of the BOD over the Board of Management:

Pursuant to Vinafor's Charter and the Internal Regulations on Corporate Governance, the BOD has supervised General Director (GD) and the Board of Management's performance in executing the resolutions passed by the General Meeting of Shareholders and the BOD during the first 6 month of 2025, as detailed below:

* Supervisory methods:

- The BoD has discussed and approved decisions through Resolutions/Decisions after each meeting and/or by collecting written opinions from BoD members on

relevant matters, thereby providing a basis for the General Director and the Board of Management to implement them.

- On a monthly basis, BoD members attend coordination meetings with the Executive Board and relevant departments to closely monitor the business operations and promptly identify and discuss arising issues.
- The BoD regularly engages in discussions and inquiries with the General Director and other members of the Board of Management regarding the development and implementation of the business plan in accordance with the objectives approved by the General Meeting of Shareholders. The General Director submits monthly reports to the BoD on the progress and results of the business plan implementation, and works with the BoD to resolve difficulties to ensure the achievement of set targets.
- The BoD maintains close coordination with the Supervisory Board in monitoring and providing feedback to the Board of Management to enhance the effectiveness of management and internal control.

* Supervisory results:

In the first half of 2025, although the Vietnamese economy showed signs of positive recovery, it continued to be significantly affected by global economic uncertainties. Factors such as prolonged geopolitical conflicts, high interest rate policies in the U.S. and other major economies, along with the rising trend of trade protectionism, have directly impacted investment flows, financial costs, and the outlook of international trade.

In the wood industry, Vietnamese enterprises continued to face numerous challenges due to declining consumer demand in key markets such as the U.S. and the EU. Notably, the U.S. market - which accounts for over 50% of Vietnam's wood export turnover-continued to impose trade defense measures, including countervailing and anti-dumping duties on certain categories of wooden furniture. Additionally, new technical regulations and trade barriers from the EU and other markets have posed further challenges for export activities.

In this context, the BoD closely collaborated with the Board of Management to direct member units in formulating and implementing timely and flexible solutions, aiming to fulfill the business plan assigned by the General Meeting of Shareholders. As a result, the General Director and the Board of Management have, overall, effectively fulfilled their roles in managing and operating business activities in line with Vinafor's strategic direction and objectives:

- During the course of operations, the General Director and the Board of Management consistently adhered to the governance framework as stipulated in the Charter, internal regulations, and the Resolutions, Decisions, and directions of the BoD.
- For long-term and complex matters, the BoD assigned the General Director to conduct research and implement them in a gradual manner, ensuring prudence and efficiency.
- On the implementation of recommendations from the State Audit Office and the Government Inspectorate: The Corporation has seriously carried out the recommended actions and has reported in accordance with the applicable regulations.

4. Activities of the Committees under the BOD:

In the first half of 2025, the Committees under the BOD operated in accordance with the regulations on personel organization; functions, tasks and methods of operation of the Committees, Vinafor's Charter and current laws.
