2. Invalid voting Ballot are those that meet any of the following conditions:

- Submitted to the Company after the specified deadline.
- Left blank (not marked in one of the boxes) or marked in two boxes simultaneously or marked in all boxes with the same content.
- Opened before the vote counting time.
- Opinion Ballot not submitted and opinion Ballots sent by the Company to shareholders but returned due to incorrect registered addresses are considered as not participating in the voting.

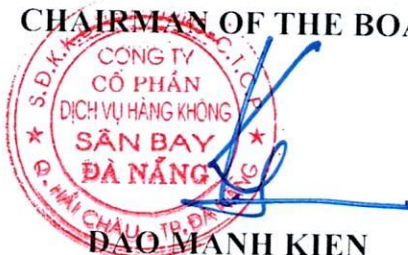
